This is a summary of the annual report for the THEATRICAL STAGE EMPLOYEES HEALTH & WELFARE TRUST, (Employer Identification No. 910853746, Plan No. 501) for the period January 1, 2022 to December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$783,089 as of December 31, 2022 compared to \$736,622 as of January 1, 2022. During the plan year the plan experienced an increase in its assets of \$46,467. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$2,839,744. This income included employer contributions of \$2,758,136, employee contributions of \$98,836, realized losses of \$(242) from the sale of assets, earnings from investments of \$22,281 and other income of \$5,295. Plan expenses were \$2,793,277. These expenses included \$188,230 in administrative expenses and \$2,605,047 in benefits paid to participants and beneficiaries.
